Chairman's Message

Dear friends of Hong Kong,

The Belgium-Hong Kong Society (BHKS) organised various events in the past year to strengthen bilateral and business ties between Belgium and Hong Kong.

In addition to the annual "Legends of Lion Dance" exhibition in Antwerp and the Chinese New Year reception, a visit of Alibaba – Cainiao eHub followed by a lunch was organised in Liège, all in the first quarter of 2024.

A Hong Kong Film Night was held in April 2024 with a reception before the screening of "The Moon Thieves". The other Hong Kong film "Bursting Point" was screened one week later.

The Dragon Boat Festival held its 10th edition in the Port of Antwerp in June, with 20 dragon boat teams taking part in the race. BHKS Education Fund sponsored the boat of the university students from KU Leuven in order to emphasise the importance of cultural and academic exchange between Belgium and HK.

BHKS Background

Founded in 1986, the objective of the Belgium-Hong Kong Society (BHKS) is to promote bilateral economic, social and cultural exchanges between Belgium and Hong Kong through a variety of business and cultural activities. In August, we supported a pop-up gallery in Ghent showcasing pictures from Fan Ho and other artists, followed by a reception and ended with a Chinese dinner party.

The 6th edition of our annual End-of-Summer business seminar in September had 86 guests and was held in the AGEAS campus in Brussels. Filip Coremans, Managing Director of AGEAS Asia explained how AGEAS had been successful throughout China and Asia through a strategy of joint ventures with local insurance companies.

BHKS continued on the rejuvenation of its board and on accruing its corporate members by inviting new structural partners and new board members.

We said goodbye to Thomas Ronse and John Verzeele as long time board members and welcomed their successors Lionel Kohn and Michèle Surinx.

The first week of December was the traditional Hong Kong Forum where all members of the Federation of Hong Kong Business Associations Worldwide were invited to celebrate, learn and connect with each other and with Hong Kong. Present were 400 business people from 40 different countries. In the Forum, we learned

about the northern metropolis in Hong Kong, a major development plan for a new international business and innovation hub at the border with Shenzhen; met with local established business owners and with young Chinese and western entrepreneurs who related their experiences of starting a business in Hong Kong. We celebrated friendship and cruised the harbour, admiring the Symphony of Lights, a giant laser and LED show involving the skyscrapers of the city.

I am happy to share that Margaret Wong, the new Chairwoman of the Federation, was elected to succeed Hans Poulis to hold the office in the next 3 years.

The Hong Kong Forum is the annual flagship event for anyone who wants to get the latest insights on doing business with Hong Kong. I invite all of you to join me at the next Forum in December 2025.

A word of gratitude to HKETO Brussels is in place. Their continued support gives us the possibility to work carefree on the promotion of business and cultural ties between Belgium and Hong Kong.

The "Legends of Lion Dance" 2024

8 – 11 February 2024





The BHKS and HKETO Brussels supported the 8th edition of the "Legends of Lion Dance" held in Antwerp, the port city of Belgium, from 8 to 11 February 2024. It offered Belgian and Chinese in Antwerp a Hong Kong film night screening "Where the Wind Blows", an exhibition showcasing Hong Kong arts and culture, and a carnival with a Hong Kong booth, food market and Chinese cultural shows, among other cultural talks and workshops during the period.

The highlight of this 4-day event was a lively lion dance parade which delighted hundreds of local spectators as it made its way to Antwerp's China Town to celebrate the start of the Chinese New Year on 10 February 2024, also the very first day of the Year of the Dragon.

Worth mentioning that the exhibition in 2024 not only displayed Lion Heads hand-embroidered and crafted in Hong Kong, but also presented a pop-up exhibition "Wanderers' Land – Cityscapes Hona Kong" featuring black-and-white drawings of Hong Kong comics artist Pen So, which depicted city scenes of local Hong Kong.





Chinese New Year Celebration Reception 20 February 2024

HKETO Brussels, with the support of BHKS, hosted the annual Chinese New Year reception in Brussels, Belgium on 20 February 2024. The reception attracted some 250 guests including officials of the European institutions, national governments, diplomatic missions, as well as senior representatives from trade and business, academia, arts and cultural sectors, media and also the Chinese community.

The opportunity was also taken to invite various Hong Kong artists to the reception to showcase their talents and to underline Hong Kong's efforts to nurture local artists in pursuit of developing Hong Kong into an international arts and cultural hub. They included a pop-up drawing exhibition of Hong Kong comics artist, Pen So, called "Wanderers' Land - Cityscapes in Hong Kong" which was also staged in Antwerp; and an original dragon-themed, action-packed dance performance "Convergence: MovINK Dragon", which was a crossover of comics, animation and Chinese kungfu, delivered by Hong Kong dance group TS Crew.







Visit to Liège eHub of Cainiao/Alibaba 15 March 2024

The BHKS organised a visit to Liège eHub of Cainiao/ Alibaba, followed by a lunch gathering with members on 15 March 2024.

In the visit, the BHKS members were updated on the latest development in the logistic industry with a briefing given by Cainiao, and were offered a tour of eHub's 12,000 sqm air cargo station and 18,000 sqm parcel sorting center to see how they make global e-commerce happen.



About Cainiao Liège eHub

Cainiao Smart Logistics Network ("Cainiao") is the logistics subsidiary of the Alibaba Group, aiming to deliver in China within 1 day and worldwide in 5 days. It utilises an innovative and open data platform to improve efficiency and customer experience throughout the supply chain. To fulfill the logistics needs of merchants and consumers for global shipments, Cainiao directly operates overseas sorting centers and has built a logistics network by partnering with over 500 logistics service providers to offer one-stop supply chain management solutions for over 200 countries/regions.

Cainiao Liège eHub started operation in November 2021 against the above background. Located next to Liège Airport, which was also crowned the best

European airport in 2021, the eHub is the largest of its kind in Europe. It helps facilitate global trade for small and medium-sized businesses via e-commerce between Asia and Europe, and also bring job opportunities and growth to the local logistics industry.



Hong Kong Film Night, Brussels International Fantastic Film Festival 10 April 2024

The BHKS, jointly with the HKETO Brussels, supported the 42nd Brussels International Fantastic Film Festival (BIFFF) held at the Brussels Expo on 9 - 21 April 2024, to promote Hong Kong's creative industry to Belgians, younger audiences in particular. Two Hong Kong films were screened in BIFFF: "The Moon Thieves" by Kim Wai Yuen (2024) and "Bursting Point" by Dante Lam and Calvin Tong (2023).

A Hong Kong Film Night was held on 10 April 2024 with a reception for the BHKS members and all friends of Hong Kong in Belgium before the screening of "The Moon Thieves". The other Hong

Kong film "Bursting Point" was screened on 17 April 2024.

All the BHKS members were invited to join the Hong Kong Film Night and offered free tickets to watch the two Hong Kong films.



Financial services, trading and logistics, tourism, and professional services are the four traditional pillar industries in Hong Kong. Announced on 16 October 2024, Hong Kong's latest Policy Address aimed at consolidating the city's advantages and **developing high value-added professional services** in areas of finance, maritime, trading, etc. Hong Kong is also committed to promoting **integrated development** of culture, sports and tourism, fostering economic diversification and new quality productive forces, to strive for building Hong Kong into a vibrant international hub for strategic enterprises and high calibre talents.

Highlights of the Policy Address 2024 which would be of interests to European travellers and friends who live, work, invest and run businesses in Hong Kong are shared below, covering different industries and sectors where opportunities are available.

Trade and services



To promote liquor trade and the development of related industries including logistics and storage, tourism as well as high end food and beverage consumption, Hong Kong reduced the duty rate for liquor (of alcoholic strength of more than 30%) with an import price of over HKD 200 (about EUR 24) from 100% to 10% for the portion above HKD 200 with effect from 16 October 2024.

International gold trading market

Hong Kong ranks among the world's largest import and export markets for gold by volume. Riding on the city's security and stability, the HKSAR Government will promote the development of world-class gold storage facilities to facilitate the storage and delivery of spot gold by users and investors in Hong Kong, which help develop the related industry chain, ranging from investment transactions, derivatives, insurance, storage, to trading and logistic services.

Commodity trading ecosystem

Commodities including metals and minerals account for more than half of the global shipping trade volume. The HKSAR Government will explore tax concessions and support measures to attract international commodity exchanges to set up accredited warehouses in Hong Kong so as to boost the maritime industry, and bring demand for related financial and professional services such as hedging activities of related futures products.

4 Mega-event economy

Hong Kong has long been recognised as Asia's world city and an events capital. The HKSAR Government will continue to bring different mega events and conferences to Hong Kong to boost not only retail and hospitality industries, but also attract elites of different sectors and tourists from around the world to personally experience Hong Kong's charm and vibrancy as an international metropolis, deepening their understanding of Hong Kong.

Arts, culture and sports

Arts, cultural and creative industries

To enhance Hong Kong's role as the international cultural exchange centre, the HKSAR Government will steer the West Kowloon Cultural District (WKCD) to establishing an industry chain of arts and creative industries. The WKCD will be branded as a must-visit destination for cultural and creative tourism. The Government will leverage the city's unique resources such as the Victoria Harbour, outlying islands, and its rich cultures, cuisines and history to promote the concept of "tourism is everywhere in Hong Kong", combined with performing arts and creative technology.

6 Sports development

The new Kai Tak Sports Park coming into operation in Q1 2025 will be a sports and mega-event landmark where the HKSAR Government continues to promote community sports, support elite sports, and maintain Hong Kong as a centre for international sports events. The countryside and coastal areas will be preserved for resorts and outdoor recreational activities as Hong Kong develops eco-tourism and sports tourism.

Strategic companies and talents

Headquarters Economy

The HKSAR Government will step up efforts to attract strategic enterprises to set up headquarters ОΓ corporate divisions Hong Kong, including proposing legislative amendments to introduce a facilitating company re-domiciliation mechanism. Besides, the validity period of multiple-entry visas for foreign staff of companies registered in Hong Kong, including non-permanent residents, will be extended to a maximum of five years to facilitate their visit to the Mainland, and their applications will enjoy priority processing.

8 New Capital Investment Entrant Scheme

Starting 16 October 2024, the New Capital Investment Entrant Scheme is enhanced by allowing the purchase of high-end residential properties, provided that the transaction price of the single residential property concerned is no less than HKD 50 million (about EUR 5.9 million), with the amount of real estate investment to be counted towards the total capital investment capped at HKD 10 million (about EUR 1.2 million). In addition, investments made through an eligible private company wholly owned by an applicant will be counted towards the applicant's eligible investment with effect from 1 March 2025.



Catching the Opportunities Arising from New Policies and Infrastructure in Hong Kong

In the face of challenges in geopolitical tensions and transformation in the global order, Hong Kong remains committed to development and progress, introducing new policies and infrastructure projects.

Since its establishment in 1966, **The Hong Kong Trade Development Council (HKTDC)** has been promoting and developing global trade, reinforcing Hong Kong's position as a dynamic two-way investment and business hub. HKTDC's promotional efforts in Europe are headed by Mr Chris Lo, Regional Director for Europe, Central Asia, and Israel. HKTDC Frankfurt manages market development in DACH and Benelux, forging collaboration and strengthening business ties. The HKTDC is your ideal partner in navigating global trade and tapping into the Asian opportunities.

A City of Trade, Resilience and Growth

Hong Kong is the world's 10th largest merchandise trading entity, and the world's fourth-largest foreign direct investment destination. It is encouraging to see that Hong Kong's exports grew by 9.9% in the first 10 months of 2024. In 2025, Hong Kong's merchandise exports are expected to enjoy moderate growth of 4%.

With 50 offices worldwide, HKTDC offers unparalleled opportunities to both Hong Kong and international businesses, especially small and medium-sized enterprises (SMEs), in the mainland and international markets. HKTDC would continue to host international conferences and trade exhibitions, lead Hong Kong companies to international platforms and provide market insights and product information via research reports and digital news channels.

Hong Kong Spirits Tax Break Welcomed by Traders

To boost the development of high-value-added industries, including logistics and storage, tourism and high-end food and beverage consumption, the import tax on spirits has been slashed from 100% to 10% since late 2024. Following

the introduction of the tax incentives, HKTDC provided a platform for the renewed interest on spirits trade and drew in a record number of spirits exhibitors at the Hong Kong International Wine & Spirits Fair.



Northern Metropolis: New Engine for the Future Development of Hong Kong

The HKSAR Government is actively taking forward the development of the Northern Metropolis, which is set to support Hong Kong in becoming an international I&T centre under the new industrial pattern of "South-North dual engine (finance-I&T)". Being a development covering about one third of the total area of Hong Kong,

the entire Northern Metropolis will eventually develop as a metropolitan with a residential population of about 2.5 million and providing about 650 000 jobs. European enterprises and startups are encouraged to capitalise on the new opportunities from building, transporation, circular design to environmental industries.

Ms Pauline Heymans, 24, Hong Kong resident. $\$ Pauline's father is Mr Francis Heymans who joined the Board of BHKS in 2024.

What inspired you to move to Hong Kong?

After finishing my bachelor's degree at Saint-Louis University in Brussels during the COVID era—a time when "student life" meant attending Zoom classes in pajamas—I was craving something more exciting. My father was tasked with setting up a new asset management company in Hong Kong and so planned to move over. With my brothers already living abroad, I thought, "Why not me?"

Hong Kong's reputation as a buzzing, dynamic hub for business and culture made it the ideal place for a fresh start. So, I took a chance, applied to universities here, and in August 2021, I began my Master's in Global Management at the University of Hong Kong. And let's be honest, the idea of trading Brussels rain for Hong Kong's skyline wasn't a hard sell!





What were your first impressions of Hong Kong?

The moment I landed, it felt like stepping into a sci-fi movie. The skyline was jaw-dropping—skyscrapers glittering against Victoria Harbour, neon signs everywhere, and an energy so palpable you could almost bottle it. The sheer density of life was overwhelming in the best way possible.


One of the highlights was discovering the incredibly welcoming young Belgian community through the Belgium-Luxembourg Chamber of Commerce and the Belgian Club. Everyone was eager to help each other settle in—whether it was navigating the city or simply sharing a beer and some laughs.



Can you share a memorable cultural shock you experienced in Hong Kong?

Oh, absolutely! My first encounter with Hong Kong's app-driven life was both hilarious and humbling. Whether it's ordering food at home, ordering a taxi, or organizing your government and bank administration, there's an app for everything.

Another surprise was the incredible efficiency of public transport. Buses, the MTR, and even taxis are so affordable and well-connected that I briefly questioned why I ever bothered driving in Brussels traffic.



Dim sum is hands-down my favorite—especially shrimp dumplings and barbecued pork buns. For an authentic experience, I'd recommend heading to *ManMo*.

But what I love about Hong Kong is its culinary diversity. From mouthwatering Indian curries to authentic Italian pasta, you can travel the world without leaving the city. A personal favorite? Exploring the food stalls at Temple Street Night Market for some adventurous street eats.

How did you adapt to the fast-paced lifestyle of Hong Kong?

At first, it felt like trying to sprint on a treadmill set to max speed! But I quickly learned to stay organized and carve out downtime. Hitting the gym daily at *Pure Fitness* became my anchor—it's amazing how it helps you lift your spirits.

During the weekends, I made it a point to explore Hong Kong's tremendous green spaces with friends. Hiking trails like Dragon's Back, short island getaways or visiting lovely beaches like Shek'O, helped me find serenity amidst the urban frenzy. I enjoy fun junk boat parties and also practice pottery, painting, deep water diving, kayaking, wake surfing and golfing. Hong Kong is basically my playground—who knew you could go from the fairway to the waves to a ceramic wheel all in one weekend?

What unique traditions or festivals have you enjoyed participating in?

The Mid-Autumn Festival was magical—lantern displays, mooncakes, and the festive atmosphere were like nothing I'd ever experienced before.

Chinese New Year blew me away with its fireworks and drone shows—it's a sensory overload in the best way possible. I've also loved exploring Hong Kong's quirky markets, like the Flower Market and Bird Market.

And, of course, the **Hong Kong Sevens** rugby tournament is an absolute must. The energy, costumes, and camaraderie make it an event like no other.











How has living in Hong Kong changed your perspective on life?

Living in a small co-living apartment teaches you to value simplicity (and creative storage solutions). But beyond that, Hong Kong has shown me how to thrive in a global, fast-paced environment while staying grounded. I've become more open-minded and adaptable, realizing that challenges are just opportunities in disquise.



What are some hidden gems in Hong Kong that you think everyone should visit?

Lion's Rock is perfect for stunning hikes with panoramic views, while Tai O offers a glimpse into a traditional fishing village. For a more laid-back vibe, **Peng Chau** island is a peaceful retreat.

And if you're feeling fancy, there's always a rooftop bar to take in the city's skyline—my personal picks are Ozone at the Ritz-Carlton (ICC), Popinjays and Sevva.



During my master's program, I realized quickly that communication with local students could sometimes feel like solving a riddle. Their polite silence often masked brilliant ideas, and once I figured that out, I learned so much from them.



At KPMG, working with Chinese colleagues was another eyeopener. Their attention to detail and preference for hierarchy challenged my more relaxed Belgian style, but it was a lesson in cultural harmony—and patience!

What advice would you give to someone considering a move to Hong Kong?

Dive in with an open mind and be ready to embrace the city's energy. While English will get you far, learning some Cantonese or Mandarin shows respect and can lead to fun interactions. I've started Mandarin lessons myself—who knows, maybe one day I'll confidently order dim sum without pointing at pictures!

What do you miss most about Belgium, and how do you stay connected to your roots?

I miss Belgian chocolate and the cozy pace of life back home. Staying connected is all about balance: regular FaceTime calls with family, celebrating Christmas in Belgium, and occasionally whipping up some Godiva's or speculoos to share a taste of home with new friends here.

What are your future plans in Hong Kong?

Hong Kong feels like a city of endless possibilities. I'm focused on growing my career, building meaningful connections, and continuing to immerse myself in its vibrant culture. Who knows? Maybe one day, I'll trade my tiny apartment for one with a view of the harbor!

In late summer 2024, Blue Lotus Gallery staged a pop-up photo exhibition "One City, Two Tales | Echoes of Hong Kong: Past and Present" in Ghent on 16 August - 7 September. The 10th Hong Kong Dragon Boat Festival Antwerp

The 10th edition of the Hong Kong Dragon Boat Festival, one of the largest of its kind in Belgium, took place at the beautiful Kattendijkdok in the City of Antwerp on 8 June 2024.

It was organised by Rotary Club Antwerpen West and Rotary Club Antwerp. International. It attracted around 6 000 enthusiastic paddlers and visitors with over 20 dragon boat teams taking part in a full day of racing. Besides the rowing competition, there were food trucks, a "Hong Kong booth" and other side acitivites to make the Festival a unique family event full of fun for BHKS members, local Belgian and Hong Kong communities.

The HKETO Brussels was the title sponsor of the Hong Kong Dragon Boat Festival Antwerp and sponsored the participation of a rowing team

from the Hong Kong Federation of Youth Groups ("HKFYG"), who visited Europe under a cultural and sports exchange programme. Members of the HKFYG also manned the Hong Kong booth, where visitors could learn more about Hong Kong culture. The Festival highlighted Hong Kong's commitment to youth development, the city's rich cultural heritage as well as its role as a leading place for holding mega events.

The other team in the race was from the KU Leuven, one of the top universities in Belgium. The dragon boat can fit 16 paddlers, a drummer and a helmsman. Our team consisted of 20 incredibly motivated people! Since the UGent decided not to participate this year due to finals, I recruited some of their team members; a few paddlers as well as the drummer. We were thus very well prepared to outperform the UGent's timing in 2018 and 2019.

Our times were 01:10.84, 01:10.71, and 01:12.04 in the qualifications, and 01:08 in the university final. We did incredibly well!





Cultural Exchange

The event is not just a competition. It's first of all a team building exercise and a cultural exchange opportunity. Our diverse team had a common goal, which worked great for us as the most important aspects of dragon boat racing are team spirit and working in sync. The festival was big fun for everyone!

We learned about Hong Kong culture and language at the Hong Kong booth organized by the Hong Kong Economic and Trade Office. Meeting the amazing rowing team from the Hong Kong Federation of Youth Groups was incredible. As often happens at international sporting events, we swapped T-shirts with the other teams.
